It is the goal of Gray Angels Inc. to place each animal into a suitable, loving, financially stable, forever home.

The potential adopter (you) represents that the information provided in the application process is true and correct to the best of the Adopter's information and belief. As the Adopter, you agree to the following provisions:

- Return policy.** Gray Angels Inc has a commitment to all its animals to care for them for their lifetime. The Adopter agrees that if he or she is unwilling or unable to care for the animal for its entire lifetime, he or she will return the animal to Gray Angels Inc. The Adopter understands that he or she is responsible for the care of the animal until he or she has delivered it to Gray Angels Inc, and will do everything within his or her power to safely return the animal. The Adopter agrees that in the event that he or she finds a suitable alternative home for the animal, he or she will contact Gray Angels Inc with the name, address and phone number of the proposed new adopter. Any proposed new adopter will be required to complete Gray Angels Inc adoption application and other requirements for adoption and obtain approval from Gray Angels Inc in writing before adopting the animal. Under no circumstances shall the adopter transfer permanent custody, ownership or possession of the animal to any one entity, including family, friends or any entity or agency, without the approval and written consent of Gray Angels Inc.
- Adoption Fees.** The Adopter agrees to pay an adoption fee to help defray Gray Angels Inc's expenses for food, sheltering, spaying and neutering, vaccinations and veterinary care.
- Identification, Licenses.** The Adopter agrees to keep an identification tag attached to a properly fitted collar (not a choke collar) that will remain on the animal at all times, whether inside or outside the house, and to obtain all city/county licenses required by local authorities.
- Veterinary Care.** The Adopter agrees to provide the animal with necessary vaccinations, heartworm tests and preventatives and flea/tick preventatives at intervals advised by the veterinarian. The Adopter agrees to obtain immediate veterinary care should the dog become sick or injured, and to take full financial responsibility for any veterinary expenses.
- Care of the Animal.** The Adopter understands that the adopted animal is an indoor pet, and agrees to allow it full access to the home. The Adopter agrees to provide the animal with fresh water, wholesome food, and adequate exercise and loving attention. The adopted animal will be leashed and under the Adopter's control when he or she is not within the confines of the Adopter's property. The adopted animal will not be tied or chained outside. The Adopter agrees to not abuse or neglect the adopted animal, and authorizes Gray Angels Inc to determine whether or not the pet has been abused or neglected.
- Seizure and Impoundment of the Animal.** If the animal is picked up by local law enforcement or animal control, and the Adopter no longer wants the animal or is not able to pay the release fee, the Adopter will immediately contact Gray Angels Inc by phone or e-mail and inform the company that the animal has been picked up and impounded, and provide the animal's location. The Adopter shall also inform the authorities holding the animal that the animal is under the ultimate ownership of Gray Angels Inc, and provide contact information for Gray Angels Inc to the authorities and request that the authorities contact Gray Angels Inc immediately. Under no circumstances will the Adopter agree to or allow the euthanasia of the animal by local law enforcement or animal control.
- Release.** The Adopter, and for his/her spouse, heirs, executors, personal representatives and assigns, agrees never to bring a claim or suit against Gray Angels Inc. The Adopter releases Gray Angels Inc, its directors, founders, employees, officers, agents, representatives, contractors, volunteers, successors and assigns from all liability arising from the adoption or behavior or actions of the animal. The Adopter understands that this agreement discharges Gray Angels Inc and its directors, founders, employees, officers, agents, representatives, contractors, volunteers, successors and assigns from any liability to the Adopter and his/her spouse, heirs, executors and assigns with respect to bodily injury, personal injury, illness, amputation, scarring, death, property damage or other loss to the Adopter.

8. **Indemnity Agreement.** The Adopter and for his/her spouse, heirs, executors, personal representatives, and assigns, agrees to indemnify and hold Gray Angels Inc harmless for all bodily injury, personal injury, illness, amputation, scarring, death, property damage or other losses, including attorney's fees and costs of litigation, that result to anyone else or any other entity because of the Adopter's negligence or liability. This includes lone acts or omissions by the Adopter as well as the combined acts of the Adopter with others.
9. **Change of Address.** In the event that the Adopter moves, he or she agrees to contact Gray Angels Inc with change of address information, so that all records can be updated and microchip information can be changed.
10. **Contract.** The Adopter understands that any failure to perform the foregoing agreement will constitute a breach of contract. In the event of any such breach of contract, the Adopter authorizes Gray Angels Inc to reclaim both possession and ownership of the adopted animal.
11. **Health.** The Adopter understands that the animal covered by this adoption contract is, as far as can be determined by Gray Angels Inc, in good health and that Gray Angels Inc is not responsible for any medical fees incurred after the adoption date. However, if a health problem develops during the first 10 days, I should notify Gray Angels Inc so the matter can be discussed.
12. **Visitation.** I agree to allow Gray Angels Inc to visit my home prior to adoption approval, along with a follow-up visit at a later date.
13. **Daycare.** Gray Angels Inc will provide six months of free doggie daycare at A Dog's Dream Daycare, LLC as part of the dog adoption agreement. During those six free months, an adopted dog must attend daycare at least one time per week, but is welcome to come five days a week if the new owner wishes. If daycare is not in the best interest of the animal, or the new owners live in another community making it impractical to bring the dog to daycare, Gray Angels Inc may waive this requirement.
14. **Landlord Approval.** Adopters who rent their home, must provide a signed letter from their landlord approving the adoption of a pet.
15. **Other Pets.** If the Adopter owns other pets, he/she must provide proof of vaccinations, including rabies and distemper/parvo for dogs; rabies and FVRCP for cats; proof of a negative FELV/FIV test for cats; and, spaying/neutering for all animals.

The Adopter agrees that he or she is legally competent to enter into this agreement, and this Agreement is binding upon the heirs, assigns, successors, personal representatives and executors of both parties.
