The Foster Parent (you) represents that the information provided in this document is true and correct to the best of the Foster's information and belief. As the Foster, you agree to the following provisions:

- Return.** Gray Angels Inc has a commitment to all its animals to care for them for their lifetime. The Foster agrees that when he or she is no longer able to foster the animal(s), he or she will return the animal(s) to Gray Angels Inc. The Foster understands that he or she is responsible for the care of the animal, and will do everything within his or her power to safely return the animal. The Foster agrees that in the event that he or she finds a suitable alternative home for the animal, he or she will contact Gray Angels Inc with the name, address and phone number of the proposed new adopter. Any proposed new adopter will be required to complete Gray Angels Inc's adoption application and other requirements for adoption, and obtain approval from Gray Angels Inc in writing before adopting the animal(s). Under no circumstances shall the Foster transfer permanent custody, ownership or possession of the animal(s) to any one entity, including family, friends or any entity or agency, without the approval and written consent of Gray Angels Inc.
- Care of the Animal(s).** The Foster understands that he or she is responsible for the care of the animal(s)—including feeding, providing water, attention, love, a place for potty time, keeping the animal(s) clean, bringing them to Gray Angels Inc for grooming, etc.—until he or she has returned it/them to Gray Angels Inc, and will do everything within his or her power to safely return the animal.
- Identification.** The Foster agrees to keep an identification tag attached to a properly fitted collar (not a choke collar) that will remain on the animal at all times, whether inside or outside the house.
- Veterinary Care.** The Foster agrees to contact Gray Angels Inc if the animal(s) needs veterinary care. Should the animal(s) need emergency veterinary care, the Foster agrees to transfer the animal(s) to either Harborside Animal Clinic at 3148 Davis Blvd., Naples, FL, 239-774-3701, or the Emergency Pet Hospital of Collier County at 6530 Dudley Dr., Naples, FL, 239-263-8010, and to notify Gray Angels Inc immediately, business phone: 239-793-6000 or emergency phone: 239-285-4977 or 239-207-9488.
- Seizure and Impoundment of the Animal(s).** If the animal(s) shall, for any reason, be picked up by local law enforcement or animal control, the Foster will immediately contact Gray Angels Inc by phone and inform the company that the animal(s) has been picked up and impounded and the animal's location. The Foster shall also inform the authorities holding the animal(s) that the animal(s) is under the ultimate ownership of Gray Angels Inc, and provide contact information for Gray Angels Inc to the authorities and request that the authorities contact Gray Angels Inc immediately. Under no circumstances will the Foster agree to or allow the euthanasia of the animal(s) prior to informing and receiving written approval from Gray Angels Inc.
- Release.** The Foster, and for his/her spouse, heirs, executors, personal representatives and assigns, agrees never to bring a claim or suit against Gray Angels Inc. The Foster releases Gray Angels Inc, its directors, founders, employees, officers, agents, representatives, contractors, volunteers, successors and assigns from all liability arising from the behavior or actions of the animal(s) while in the care of the Foster. The Foster understands that this agreement discharges Gray Angels Inc and its directors, founders, employees, officers, agents, representatives, contractors, volunteers, successors and assigns from any liability to the Foster and his/her spouse, heirs, executors and assigns with respect to bodily injury, personal injury, illness, amputation, scarring, death, property damage or other loss to the Foster.
- Indemnity Agreement.** The Foster and for his/her spouse, heirs, executors, personal representatives, and assigns, agrees to indemnify and hold Gray Angels Inc harmless for all bodily injury, personal injury, illness, amputation, scarring, death, property damage or other losses, including attorney's fees and costs of litigation, that result to anyone else or any other entity because of the Foster's negligence or liability. This includes lone acts or omissions by the Foster as well as the combined acts of the Foster with others.

9. **Change of Address.** In the event that the Foster moves, he or she agrees to contact Gray Angels Inc with change of address information so that all records can be updated.
10. **Contract.** The Foster understands that any failure to perform the foregoing agreement will constitute a breach of contract. In the event of any such breach of contract, the Foster authorizes Gray Angels Inc to reclaim possession of the fostered animal.
12. **Visitation.** Foster agrees to allow Gray Angels Inc an initial home visit, followed by occasional additional visits to ensure that the terms of this agreement are being observed.
13. **Daycare.** For dog fosters, if it is in the best interest of the dog as determined by Gray Angels Inc volunteers, Foster parents agree to bring the dog to daycare at A Dog & Cat's Dream at least one time per week.
14. **Landlord Approval.** Fosters who rent their home, must provide a signed letter from their landlord approving the foster of an animal.
15. **Other Pets.** If the Foster owns other pets, he/she must provide proof of vaccinations, including rabies, bordetella, and distemper/parvo for dogs; rabies and FVRCP for cats; proof of a negative FELV/FIV test for cats; and, spaying/neutering for all animals.

The Foster agrees that he or she is legally competent to enter into this agreement, and this Agreement is binding upon the heirs, assigns, successors, personal representatives and executors of both parties.
